Treasurer's Report:

Treasurer's report printed and provided by Matt Neff. He included financial statement for the last two months for the club, along with an income statement for the 2023 calendar year. Account balance is around \$35k. The Scholarship monies have been distributed.

- -John Rudy- Heather Roe motioned for \$150 donation to Eagle Fire Company for their assistance at the race. Motion approved.
- -YTI is allowing us to use their building / facilities for the Springettsbury race this year with no charge, eliminating the need for portapotty rentals. They will have information available for anyone interested in attending YTI.
- -Jacobus 5 miler will be held at Dallastown Intermediate School again this year. We need to check and see if Christ United Methodist Church will be providing finish line refreshments again this year or if the club will need to provide.
- -Indian Rock will again begin at Regent Glen's Fairway Table parking lot. The restaurant is working on a

discount for runners who eat at the restaurant after the race and will set up a booth for anyone interested in information on joining the country club.

Northeastern- We are still working on approvals

-Hanover 7 Miler- We are approved in Union Township, Adams County but still need to send a certified letter to all residents along the course in the township.

A member of York Runners board needs to attend the township board meeting this week to obtain approval in West Manheim Township.

White Rose 5 Miler- \$5,000 Donation check was presented to Bell Socialization Services. Karen Mitchell's name needs to be removed from the White Rose domain so that she stops receiving emails from the website
